(6) Business Description

Eight Point Wind, LLC is a limited liability company formed on January 29, 2016 in Delaware that will develop, own, operate and maintain a wind powered wholesale generating facility in Steuben County, New York. Eight Point Wind, LLC is a wholly-owned, indirect subsidiary of NextEra Energy Resources, LLC (NextEra), which is located in Juno Beach, Florida. NextEra has a portfolio of generating facilities (including wind, solar, natural gas and nuclear energy resources) totaling more than 19,880 megawatts of capacity located in 29 states and Canada, and is the world's largest generator of renewable energy from the wind and sun.

NextEra is a subsidiary of NextEra Energy, Inc. (NYSE ticker: NEE) which is a leading clean energy company with consolidated revenues of approximately \$16.2 billion, approximately 45,900 megawatts of generating capacity, and approximately 14,700 employees in 30 states and Canada as of year-end 2016. Headquartered in Juno Beach, Florida, NextEra Energy's principal subsidiaries are Florida Power & Light Company, which serves approximately five million customer accounts in Florida and is one of the largest rate-regulated electric utilities in the United States, and NextEra (as previously described).
